30 minutes cook banana Salmon stove top on low
15 minutes cook both in stove on 350°

Cut up a red bell pepper or yellow, dice 7 potatoes Idaho, dice one onion purple, and place pink salt, black pepper over the ingredients in pan, add olive oil underneath, turn oil over the ingredients, then place in oven checking and turning every 30 minutes.

Add half a salmon thawed on the surface on a pan over the stove top, add olive oil, bananas, pecans and shred with spatula and fork as it cooks for 30 minutes. Turning often.

Add salmon and it's additives to the potatoes and place in oven for another 15 minutes then serve.
